You can make your gift to the church in the form of appreciated stock. As the donor, you will be credited with the full market value of the shares you gift to the church while avoiding capital gains tax on their appreciation. - Be sure to indicate if you would like offering envelopes, if you would like to use automatic withdrawal to pay your pledge, or if you would like to pay your pledge with a stock contribution.
- Completed cards will be collected during the service so that we may dedicate them to God's service. There will also be a box in the Narthex should you prefer to place your pledge card there.
